Rules and Regulations

- 1 Entry Fees, as stated in each section.
- 2 Members and Judges will be admitted to the grounds on production of their Membership tickets or passes. All persons not members shall pay for admittance to the Show the sum prescribed unless otherwise provided with a pass from the Secretary.
- 3 All exhibits must remain at the Show until the section's Chief Steward approves the removal of same, or prize money forfeited.
- 4 Awards will be made in all classes unless otherwise specified, if the exhibit is deemed of sufficient merit, and should any person make any entered as non-competitive by the Secretary. The Committee reserves the right to receive such exhibits if space permits, if of sufficient merit for exhibition purposes only.
- 5 In all classes of single entry, it shall be at the discretion of Judge to award a prize, if exhibit is deemed by him to be of sufficient merit. The Society has the right to refuse entries without giving a reason.
- 6 Exhibits are not allowed to compete in classes and afterwards in collections.
- 7 No entry fee necessary for Championships in any section, and only first and second prize animals will be eligible for championships. No animal allowed to compete in Championship unless entered in class.
- 8 Exhibitors when called upon by the Steward or Committee shall prove the correctness of their certificate of entry.
- 9 Any breach of this regulation will render the exhibitor liable for forfeiture of any prize, and open to disqualification for future exhibitions. Any exhibitor refusing or preventing awards to be affixed, interfering with Show Officials, refusing to obey instructions of the Stewards, interfering with exhibits or detention of exhibits, or Society's property, may render himself or herself liable to disqualification for a period not exceeding three (3) years. Abusive language and insulting behaviour, wilfully making wrong entry of exhibit or competitor, entry of fraudulent exhibitor or competitor may render an exhibitor to be disqualified for five (5) years.
10. The Society reserves the right of refusing to admit any exhibit to the grounds where there is a reason to suspect it is either diseased or dangerous, or to remove any such exhibit from the exhibition
- 11 The Society will not under any circumstances hold itself liable for any accident on the grounds or premises.
12. Exhibitors and persons admitted to the grounds shall be subject to the Rules and Regulations and the Orders of the Stewards

13. Any exhibitor removing his exhibit from the stall allocated without the consent of the stewards will be disqualified from competing.
14. The Society will not under any circumstance hold itself liable for any accident, loss, damage or non-delivery of livestock or other exhibits at the Society's Show, and it shall be a condition of entry that each exhibitor shall hold the Society blameless and indemnify it against any legal proceedings arising through any accident, loss, non-delivery or damage whatsoever.
15. No Steward, Officer or Member of the Committee wearing the Society's badge shall lead, bring into the ring, or hold an exhibit before a Judge, while same is being judged. Breach of this rule shall disqualify the exhibit.
16. No ribbon other than those won at the current Show is to be worn or displayed at the Showground, but such ribbons may be affixed to stall after finally judged.
17. Protests may be lodged at the Secretary's office in writing with a fee of \$20 not later than one (1) hour after the judging of the event, in which the protest is to be made. If the protest is considered frivolous by the Committee, the deposit shall become forfeited to the Secretary.
18. No stock shall be permitted to run loose on the grounds during the show days and nights, unless by permission of the Stewards or Secretary.
19. Dogs, other than those owned by members of the Canine Control Council, must be kept in closed float or vehicle or else on a short leash and must be suitably muzzled as to prevent it being able to injure or bite any person or other animal.
20. The prizes will be paid within 30 days by the Committee, who will require a signature of acceptance for same. All prize money not claimed or prize cheques not presented by 30th June, immediately following the Show will revert to Society funds unless special arrangements are made with the Secretary. The Committee reserves the right to substitute special prizes of equal value for any of the above or aforementioned schedule of prizes.
21. Conditions of Competition: The By-laws and Regulations of the Queensland Chamber of Agricultural Societies By-laws or Regulations comprised herein, shall be the condition of competition and all exhibitors and competitors shall make their entries or enter into competition on this express condition.
22. In the event where insufficient entries are received the Society reserves the rights to cancel the competition or reduce the advertised prize money.
23. Judges have the power to withhold any prize if they consider the exhibit of insufficient merit.

2019 Conditions of Entry.

1. All exhibitor's "**PLEASE READ**" the Conditions of Entry.
2. The exhibit entered by the child **MUST** be his/her own original design or creation.
3. The exhibit "**MUST NOT**" be a dishing or copy worked from instructions either on boxes or sets.
4. The exhibit "**MUST**" be constructed entirely from "**LEGO**".
5. **NO "MEGA BLOCK"** or other brands to be incorporated in the design. If the exhibit entered contains any "**NONE LEGO**" pieces, the exhibit will be disqualified.
6. **N.B** Only **1 (one)** entry per **1 (one)** child will be accepted.
7. If **1 (one)** exhibit is entered with more than **1 (one)** name, the exhibit will be disqualified.
8. Exhibits must be set up on a tray or firm base for easy movement. Base or tray to measure **NO LARGER** than **38cm x 38cm**. (***Blue Tac is allowed***) Lego Base Boards are permitted.
9. Overall height of exhibit (***including Base***) "**MUST NOT**" exceed **30cm**.
10. Exhibits entered **MUST** be clean, free of Dust, Scratches and Soil.
11. Exhibits **MUST** be left at the **Education / Trade Hall** at the Showgrounds **before 4.00pm Monday 29th April 2019**.
12. **NO** entries will be excepted at the **Show Office**.
13. "**NO LATE ENTRIES WILL BE ACCEPTED**"
14. Entry forms **MUST** state **Age**, **Boy** or **Girl**, **Name of Exhibitor**, contact **Phone number**, and **Name of exhibit / creation**.
15. **Each Entry form MUST have Parent/Guardian Signature.**

16. The entry form **MUST** be left with the Exhibit. .
17. Exhibits must remain on display during the Show and can be collected after **10.00am Monday 6th May 2019** or prior arrangements are made with the Chief Steward.
- 18.. The Show Society and Stewards will **“NOT”** be held responsible for any exhibit not collected by the time stipulated in the conditions of entry. (**Please read No. 17**)
19. All exhibitors pay gate entrance fee unless in possession of a pass.
20. Points will be given for, ***Creativity / Originality, Design, and Skill/Technique.***
21. The Judge’s decision is final and exhibits not following “Conditions of Entry” will have points deducted.

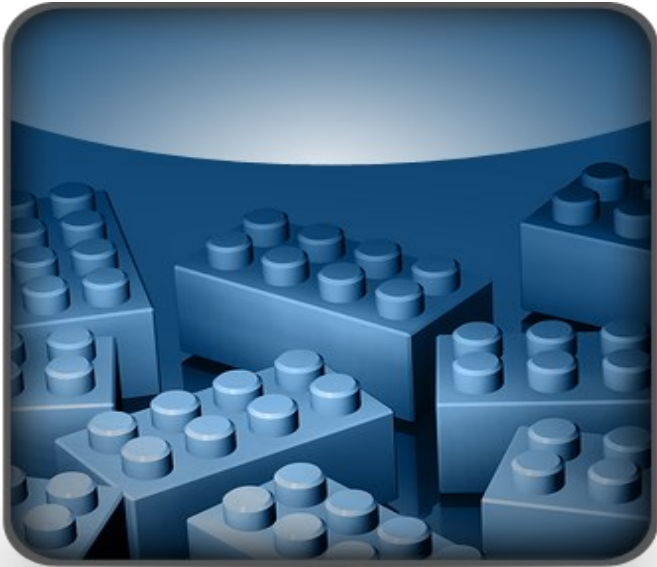
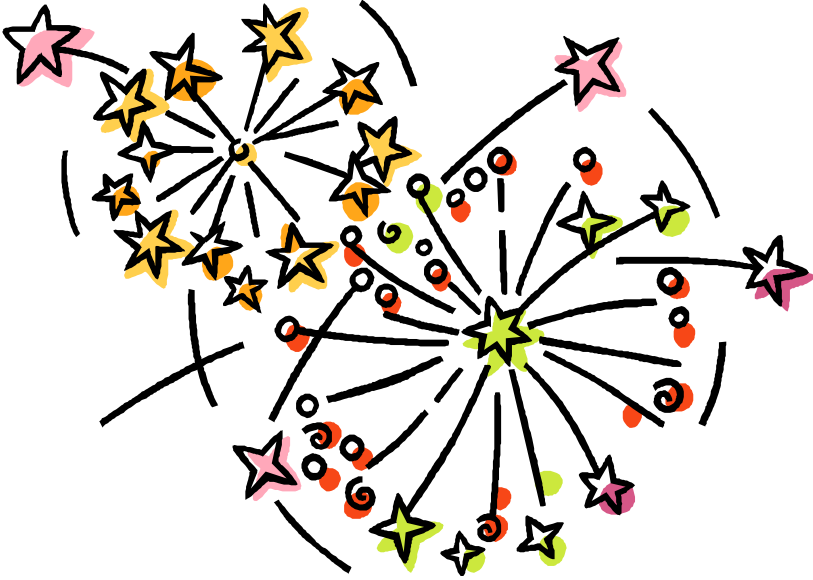
